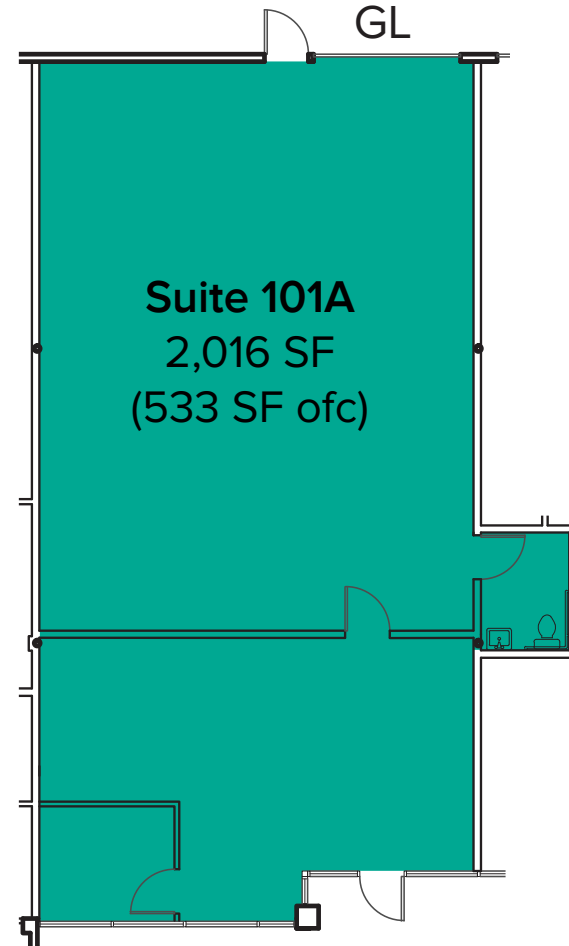


# BUILDING 3 (11824) FLOOR PLAN

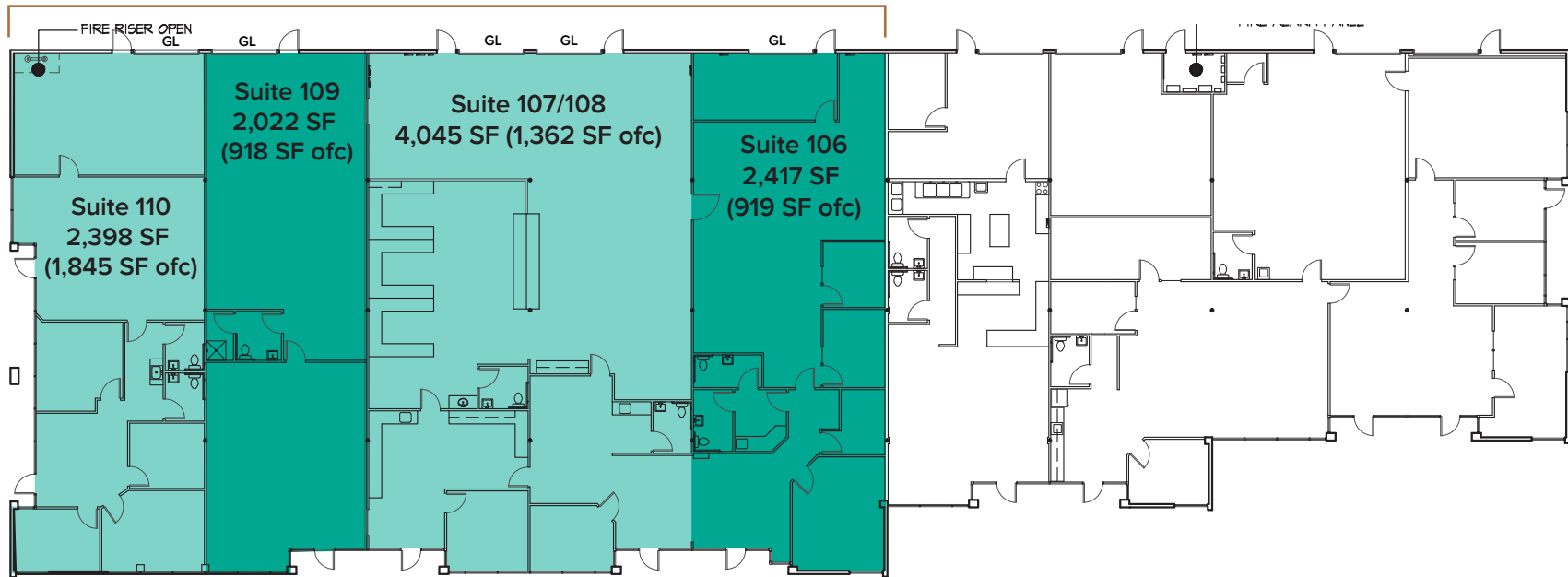
